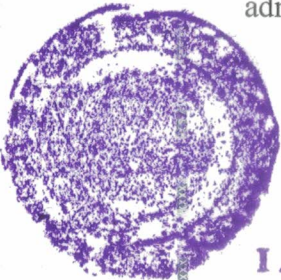

The Society does not possess the characters of the proprietorship. It is purely under the administration of our Society, formed by the permanent members of the Society.

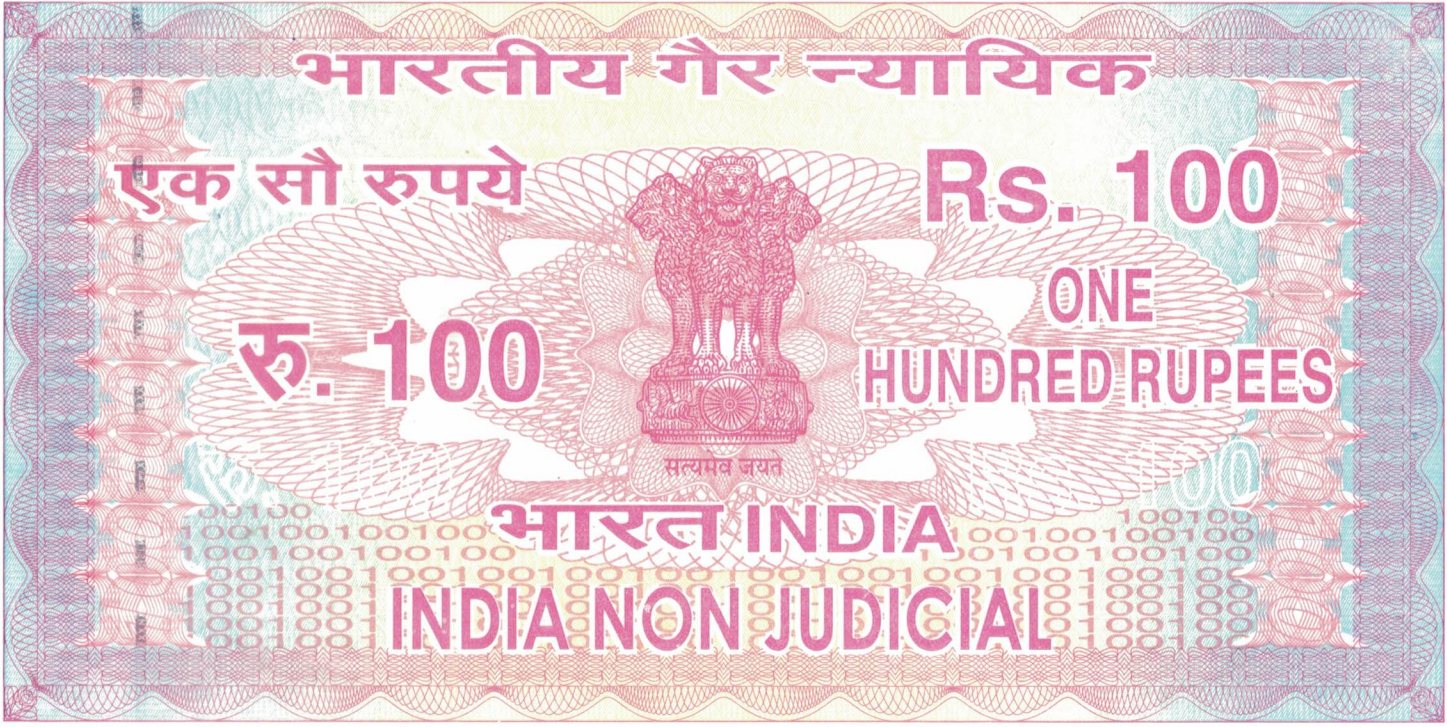
